PERSONAL DATA PROTECTION

Dear Customers,

below we provide information on the terms and conditions of the process of processing and protection of personal data, applicable in "TVK Telewizja Kablowa Elżbieta Zjawiona", in accordance with the regulations of the Regulation of the European Parliament and the Council of the EU 2016/679 of 27 April 2016, regarding the protection of personal data (GDPR) and Polish provisions concerning protection of personal data.

1. The administrator of the personal data of our Customers and Users of the website www.housesecretsbg.com is "TVK Telewizja Kablowa Elżbieta Zjawiona" based in Wrocław, ul. Kolisty 14, 54-152 Wrocław (hereinafter: Administrator, TVK).

2. Customers provide their personal data voluntarily and may withdraw their consent to the processing of this data at any time.

3. Customers' personal data is processed in order to:

- a) implement legal provisions;
- b) protect the Administrator's legitimate interests,
- c) successfully conduct Administrator's promotional and commercial activities connected with the Administrator's products (e.g. House Secrets Board Game).

4. The Administrator collects personal data for the purpose of activities connected with promoting the Administrator's products and for the purpose of implementing contracts connected with publishing and promoting its products:

- a) entities providing the Administrator with consultancy services (including legal, accounting, auditing, tax), to the extent necessary to fulfill the obligations imposed by law, as well as to protect legitimate interests pursued by the Administrator;
- b) other entities and persons, including state authorities at their request and only in cases and to the extent provided for by the rules of law;

5. The administrator informs that the subject of personal data collected by the Administration has the following rights:

- a) the right to access, rectify and update personal data, as well as transfer the aforementioned personal data;
- b) the right to delete or request the restriction of the processing of the aforementioned personal data in relation to the current method of data processing;
- c) the right to formally object to the methods of data processing specified by the regulations of law as well as the right to file a complaint to the regulatory organs responsible for the

protection of personal data in Poland - in the event deemed that the processing of personal data violates the abiding law;

6. The Customer's voluntary delivery of the Customer's personal data is necessary to implement this agreement and perform it properly (including the newsletter purposes, which requires collecting personal data). Providing data is voluntary, but failure to provide them will prevent the implementation of this agreement with TVK.

7. The administrator provides appropriate technical and organizational measures to ensure the security of personal data collected to prevent unauthorized access to data and data processing in a manner that is unlawful. Personal data may be transferred to a third country or international organization to the extent necessary from the information obligation in relation to promotional campaigns launched on other platforms.

8. The Administrator stores personal data for as long as it is specified by applicable law (including tax and accounting, provisions on the limitation of claims), with due diligence in securing and protecting them.

9. In order to exercise the rights related to the protection of personal data, the Customer can contact the Administrator at the correspondence address indicated in point 1 and email address contact@housesecretsbg.com.

10. The Administrator will make every effort to enable the Customers to have an unfettered access to their personal data and fully exercise their rights. If the information on the protection of personal data provided above is not fully understood by the Customer, it's possible to contact the Administrator for additional clarifications.

By reading this Privacy Policy, the Customer agrees that the information specified in the document is clear and understandable. Therefore, the Customer is aware of the right to contact the Administrator at any time in order to implement the above mentioned rights.

Consent to the processing of personal data

By reading this Privacy Policy, the Customer agrees and gives consent for storage, processing and the update of their personal information when using the Administrator's services, such as newsletter and subscription services, and marketing services, such as promotional campaigns, provided that they're used for the purpose and scope necessary to implement the Administrator's promotional activities, such as promoting and selling the Administrator's products (e.g. House Secrets Board Game).

The Customer can always contact the Administrator if the Customer's e-mail address has changed, the Customer would like to the Administrator to replace the previous e-mail address or remove it entirely.

Consent to the processing of personal data

The Customer agrees to receive from “TVK Telewizja Kablowa Elżbieta Zjawiona” commercial information via e-mail, commercial information within the meaning of the Act of July 18, 2002 on the provision of electronic services (Journal of Laws of 2002, No. 144, item 1204, as amended), until this consent is withdrawn.
